CMMC Overview

The United States Department of Defense (DoD) initiated the Cybersecurity Maturity Model Certification (CMMC) to enhance and strengthen the cybersecurity posture of DoD contractors across the Defense Industrial Base (DIB).

Compliance with CMMC requires that DoD contractors undergo a detailed cybersecurity audit and certification at a level that is equal with the risk to the information within their care.

DoD, by developing the CMMC, is essentially informing the defense contractors that security is crucial and that they have to meet specific cybersecurity standards to be taken into account for a contract in the future.

CMMC Level Types of Certifications

CERTIFIED CMMC PROFESSIONAL

This type of certification is the essence for anyone who will be performing any level of CMMC assessment. Certified CMMC Professional (CCP) can be part of an assessment team under the supervision of a Certified CMMC Assessor. In order to become a CCP, the respective candidate must successfully complete a CMMC-AB Certified CMMC Professional Training from a PECB Licensed Training Provider. Taking the exam is optional for those who wish to operate as Certified CMMC Professionals only. More information on becoming a Certified CMMC Professionals can be found [here](#).

CERTIFIED CCA-1 ASSESSOR

The Certified CCA-1 Assessor is the baseline certification for candidates who wish to conduct CMMC Maturity Level 1 standard assessments. In order to achieve this certification, candidates need to be Certified CMMC Professionals first. After passing the CCA-1 certification exam, Assessors must schedule and conduct their first assessment under the supervision of an AB staff or an AB-contracted senior assessor.

CERTIFIED CCA-3 ASSESSOR

Candidates who wish to perform CMMC Level 3 assessments must become CCA-3 Assessor certified.

There are a few additional requirements with regards to citizenship and background screening:

- ✓ Level 3 Assessors must be U.S. citizens, unlike CCA-1 Assessors who only need to demonstrate legal residency.
- ✓ Level 3 Assessors must pass a National Agency Check, DHS Suitability credential, or other DoD accepted clearance. CCA-1 Assessors may operate with a commercial background check.

CERTIFIED CCA-1 ASSESSOR

In order to conduct CMMC assessments at all maturity levels, candidates are required to have a CCA-1 certification. A significant requirement for this level is that candidates should possess experience performing CMMC assessments. CCA-1 certification requires that they perform 15 CMMC Level 3 assessments as well.



Who should attend the PECB CMMC training course?

- ✓ Employees of DoD contractors that make up the Defense Industrial Base (DIB)
- ✓ Regulatory compliance officers and legal team members
- ✓ Cybersecurity managers
- ✓ Consultants looking to provide CMMC guidance
- ✓ Individuals starting the CMMC-AB Certified CMMC Assessor or Certified CMMC Instructor career path
- ✓ Anyone looking to build a foundation of knowledge and skills around the new CMMC requirements

What are the prerequisites to get certified?

Certified CMMC Professionals and Certified CMMC Assessors must meet citizenship requirements as defined by the CMMC-AB:

- ✓ **Certified CMMC Professionals and CCA-1 Assessors:** The candidate must be a U.S. person (U.S. citizenship is required to participate as a team member on ML-2 assessments.)
- ✓ **CCA-3 and above:** The candidate must have a U.S. citizenship.
- ✓ **International C3PAOs:** The candidate must be a citizen of the country where the C3PAO is based, and will be authorized only to assess contractors based in that country. The U.S. Government must establish bilateral agreements with other countries with respect to CMMC prior to the issuance of any authorizations related to CMMC.



PECB's Role and Responsibility to CMMC and Its Clients

PECB, as an official Licensed Partner Publisher, will offer the training course to the candidates through its Licensed Training Providers.

The exam and certification will be managed by CMMC-AB only.

Thus, PECB will not offer exam and certification services for CMMC. Candidates who complete the PECB training course will need to go directly through CMMC-AB for the next steps.
